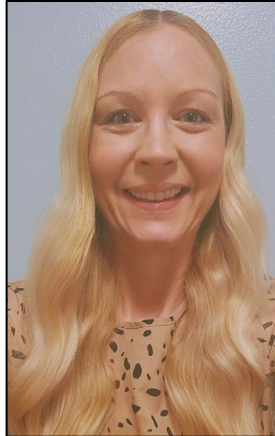

**Local court reporter earns \$4,000 New Professional Reporter Grant**  
*Katie DeLong of Milwaukee, Wis., wins top honors*

**RESTON, Va., Aug. 8, 2024** — The National Court Reporters Foundation (NCRF), the philanthropic arm of the National Court Reporters Association (NCRA), presented the [New Professional Reporter Grant](#) in the amount of \$4,000 to Katie DeLong, an official court reporter from Milwaukee, Wis. NCRA is the country’s leading organization representing stenographic court reporters, captioners, and legal videographers. The announcement was made at a special awards luncheon at the 2024 NCRA Conference & Expo held Aug. 1-3 in Louisville, Ky.

NCRF awards the annual New Professional Reporter Grant to a reporter who is in his or her first year of work, has graduated within a year from an NCRA-approved court reporting program, and meets specific criteria, including a grade point average of 3.5 or above, a letter of recommendation, an answer to an essay question, and is actively working in any of the career paths of judicial (official/freelance), CART, or captioning.

“I am shocked and humbled to have been selected to receive NCRF’s New Professional Reporter Grant knowing how tight the competition was,” said first-place winner Katie DeLong. “It is so exciting to know that so many hard-working, deserving new reporters applied. The transition from court reporting student to working reporter is an overwhelming time of transformation and learning, and along with that comes the expense of getting started in this profession.”
