Local court reporting instructor to serve as National Vice President Cathy Penniston, from Waukee, Iowa, named NCRA Vice President

RESTON, Va., Aug. 6, 2024 — The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Cathy Penniston, RPR, CRI, a court reporting instructor and broadcast captioner from Waukee, Iowa, will serve as its 2024-2025 Vice President. At the state level, Penniston served as president, vice president, and secretary of the Iowa Court Reporters Association, and is the recipient of the Roy Voelker Memorial Award for Distinguished Service for the court reporting profession of the state of Iowa. She also received the Indian Hills Community College Vision Award Alumni Entrepreneur of the Year in 2014.
