Local court reporting student wins scholarship Gillian Hassert from Summit, N.J., is recipient of \$500 award

RESTON, Va., Dec. 4, 2024 —The National Court Reporters Association (NCRA), the country's leading organization representing stenographic court reporters, captioners, and legal videographers, has announced that Gillian Hassert, a court reporting student from Summit, N.J., and a student at Alfred State College in Alfred, N.Y., is the 2024 recipient of the Association's Council on Approved Student Education (CASE) scholarship prize of \$500.

Four additional scholarships were also awarded in the amounts of \$250, \$750, \$1,000, and \$1,500. To be eligible to apply, students must currently be attending an NCRA-approved court reporting program, have an exemplary academic record, and have passed one skills test writing at 160 wpm or above at the time of submission. In addition, applicants must submit an essay on a topic chosen by CASE.

Hassert said she learned about the court reporting profession from a friend of a friend, attended a free introductory course, and was approached by Alfred College about starting its court reporting program.

"I'm also an actor, and I wanted to find a career that I could pursue that would run parallel to performing. Since I often go through stretches of unemployment with performing, this was a perfect complement," Hassert said. "Eventually I hope to be able to take depositions during the day and perform at night!"

Currently working on her exit exams, she anticipates graduating later this month. She plans to take her Registered Professional Reporter (RPR) exam in the spring of 2025 and hopes to work as a freelance court reporter taking depositions during the day while she pursues her acting career at night. She said she also hopes to eventually shift into captioning to serve the deaf and hard-of-hearing communities with the ultimate goal of captioning live performances.

Hassert added that she plans to use the scholarship funds to help offset the costs she has already incurred purchasing a new steno machine and soon to be professional software.

The NCRA A to Z^{\otimes} Intro to Steno Machine Shorthand program, a free online six-week introductory course, lets participants see if a career in court reporting or captioning would be a good choice for them. The program is an introduction to stenographic theory and provides participants with the opportunity to learn the basics of writing on a steno machine. There is no charge to take the course, but participants are required to have access to a steno machine or an iPad they can use to download the iStenoPad app.
